E-WASTE DISPOSAL AND RECYCLING AGREEMENT

This E-Waste Disposal and Recycling Agreement ("Agreement") is made on 17th August 2022 by and between Sri Bhagawan Mahaveer Jain First Grade College, Geetha Road, Robertsonpet, Kolar Gold Fields – 563 122, Kolar District, Karnataka (hereinafter referred to as SBMJFGC), which expression shall unless repugnant to the context include its legal representatives, administrators, executors, nominees, successors and assigns of the first part.

AND

E-Cycle Solutions; Address: # 41, 7th Cross, Hoysala Circle, Bahubali Nagar, Jalahalli Village, Bengaluru-560013,

- Material** - Material is hereinafter defined as all forms of outdated CPU, monitors, key boards, wires, LED bulbs, fluorescent bulbs etc Sri Bhagawan Mahaveer Jain First Grade College may want to recycle.
- Services - E-Cycle** shall provide following services to SBMJFGC, collection and removal of material will be initiated by SBMJFGC, within 7 days of written request to E-Cycle
 - The Material collected from the SBMJFGC, will be recycled at one of the E-Cycle locations (Bangalore). This will be decided considering business reasons like logistics cost and other operational constrains.
 - SBMJFGC will notify E-Cycle for pick up as per the accumulation of Waste from their office premises, Collection of the Material, within 7 working days or case to case from date of notice by authorised person of SBMJFGC from its premises.
 - Recycling/Destruction/Asset Management services will be carried out at the facilities of E-Cycle or at the approved downstream vendor facilities of E-Cycle.

- (iv) **E-Cycle** shall destruct the entire quantity of Material within 15 working days of receipt of Material. SBMJFGC representative may also witness the destruction at E-Cycle's facility or request written confirmation by Certificate of destruction form E-Cycle

4. **E-Cycle Representation and Warranties –**

- 4.1 In the performance of all Services to be provided hereunder, **E-Cycle** agrees to comply with all applicable permits, all central, state, and local laws, regulations and ordinances and all duly constituted authorities and upon request shall furnish copies thereof to SBMJFGC.
- 4.2 **E-Cycle** will be responsible for the statutory compliances including environmental compliances pertaining to the recycling activities and Services like Collection, Transportation & Storing of E-waste and also SBMJFGC will not in any way be responsible for the same once the scrap material is handed over to **E-Cycle**.
- 4.3 **E-Cycle** shall keep and retain adequate books and records and other documentation consistent with and for the periods required by applicable regulatory requirements and guidelines pertaining to performance of the Services required by this Agreement. Said records, books and documentation relevant to SBMJFGC shall be available for inspection by SBMJFGC upon advance notice with reason.
- 4.4 **E-Cycle** shall not resell the Material in the original form which has been collected from SBMJFGC except after totally destroying the Material for purpose of recycling.
- 4.5 **E-Cycle** agrees and undertakes to indemnify SBMJFGC for any liability, claims including third party claims, legal actions against SBMJFGC, arising out of any negligent action or wilful misconduct by **E-Cycle**.
- 4.6 **E-Cycle** shall comply at their own expense with all applicable local, national, regional and international laws, ordinances, regulations, codes, standards, directives and international conventions and agreements to the extent that any of them have the force of law, including, as applicable, but not limited to (a) anti-bribery laws, conventions and/or directives of the country in which **E-Cycle** conducts business as it relates to this agreement including, but not limited to, the U.S. Foreign Corrupt Practices Act ("FCPA"), the Organization for Economic Cooperation and Development Convention on Combating Bribery of Foreign Public Officials ("OECD") and the Organization of American States ("OAS") convention bilateral anti-corruption treaty (Inter-American Convention Against Corruption), including but not limited to offering of payment or transfer of anything of value as defined in the FCPA and other laws implementing the Convention on Combating Bribery of Foreign Public Officials in International Business Transactions.

In addition, **E-Cycle** shall comply at their own expense with all laws, ordinances and /or directives of the country in which it conducts business as they relate to the Universal Declaration of Human Rights, Child Labour Laws, Data Privacy Laws, Criminal Reporting Laws, Environmental, Health and Safety Laws or any similar laws in performance of its obligations under this Agreement.

- 4.7 As an integral part of this Agreement, **E-Cycle** hereby represents that they or any of their officials or representatives shall not give or promise to give any money or gift to any employee / official of SBMJFGC to influence its decisions regarding this Agreement, nor shall they exert or utilize any unlawful influence to solicit or secure this Agreement through a promise to pay a commission, percentage, brokerage or contingent fee. 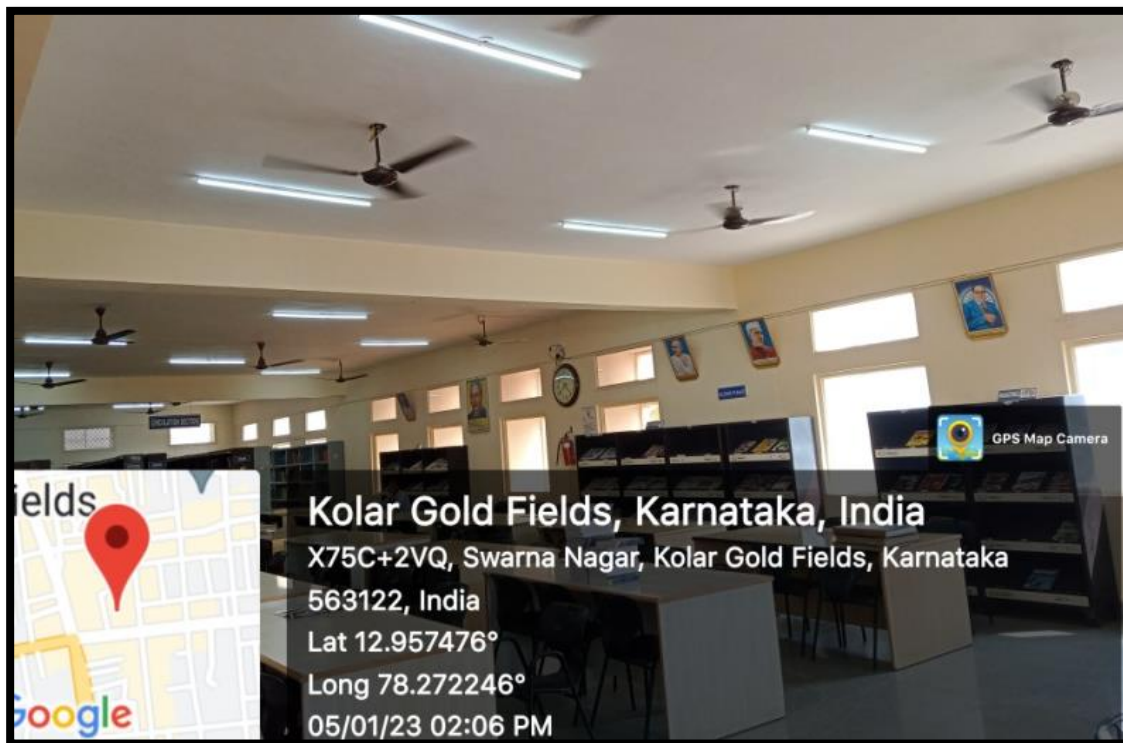
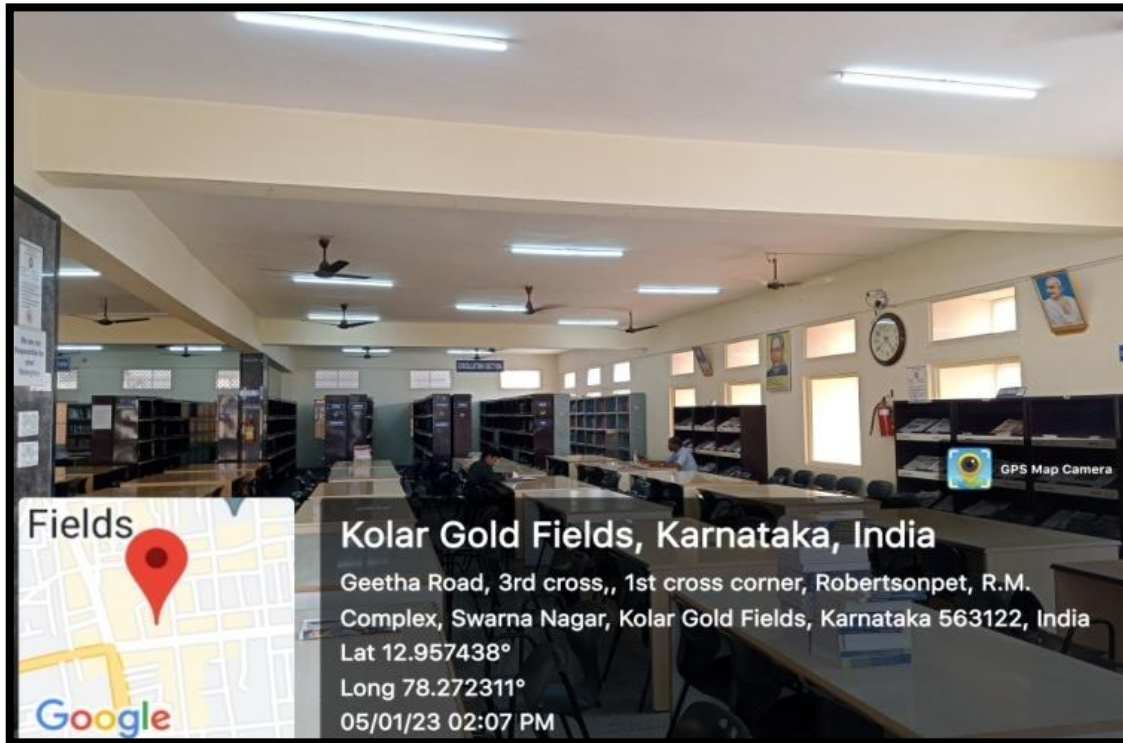


Infrared Motion Sensor Light in the Staircase



Infrared Motion Sensor Light in the Basement

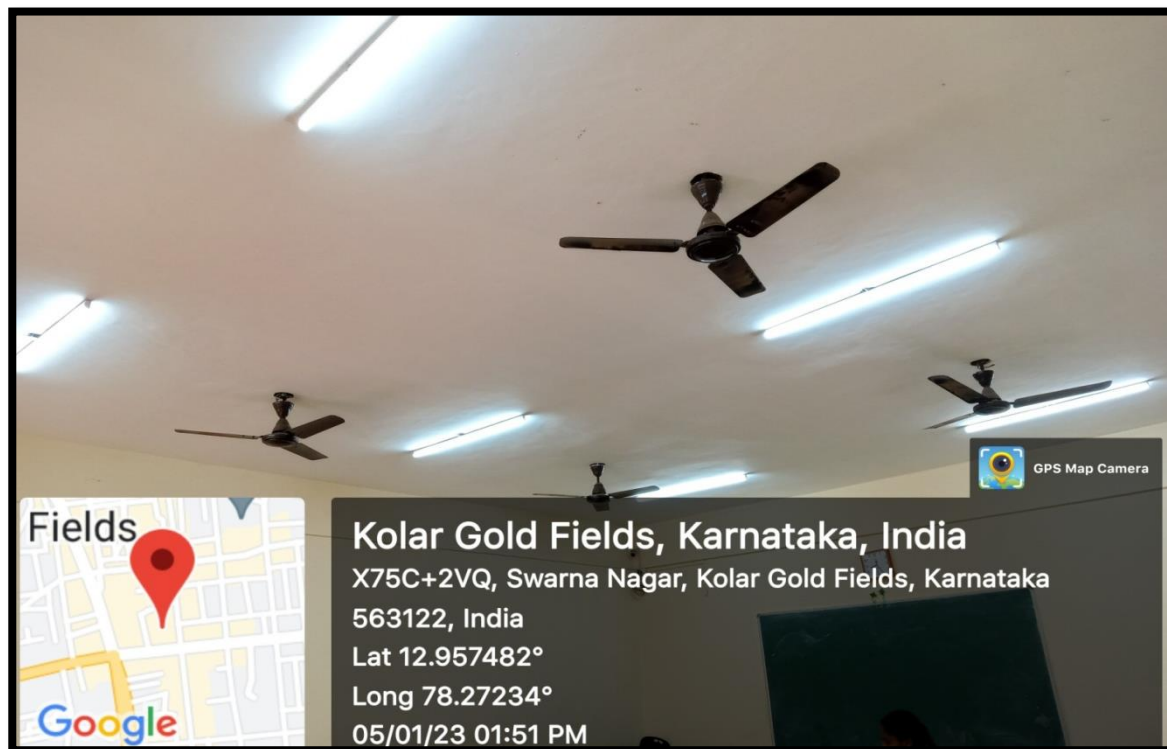

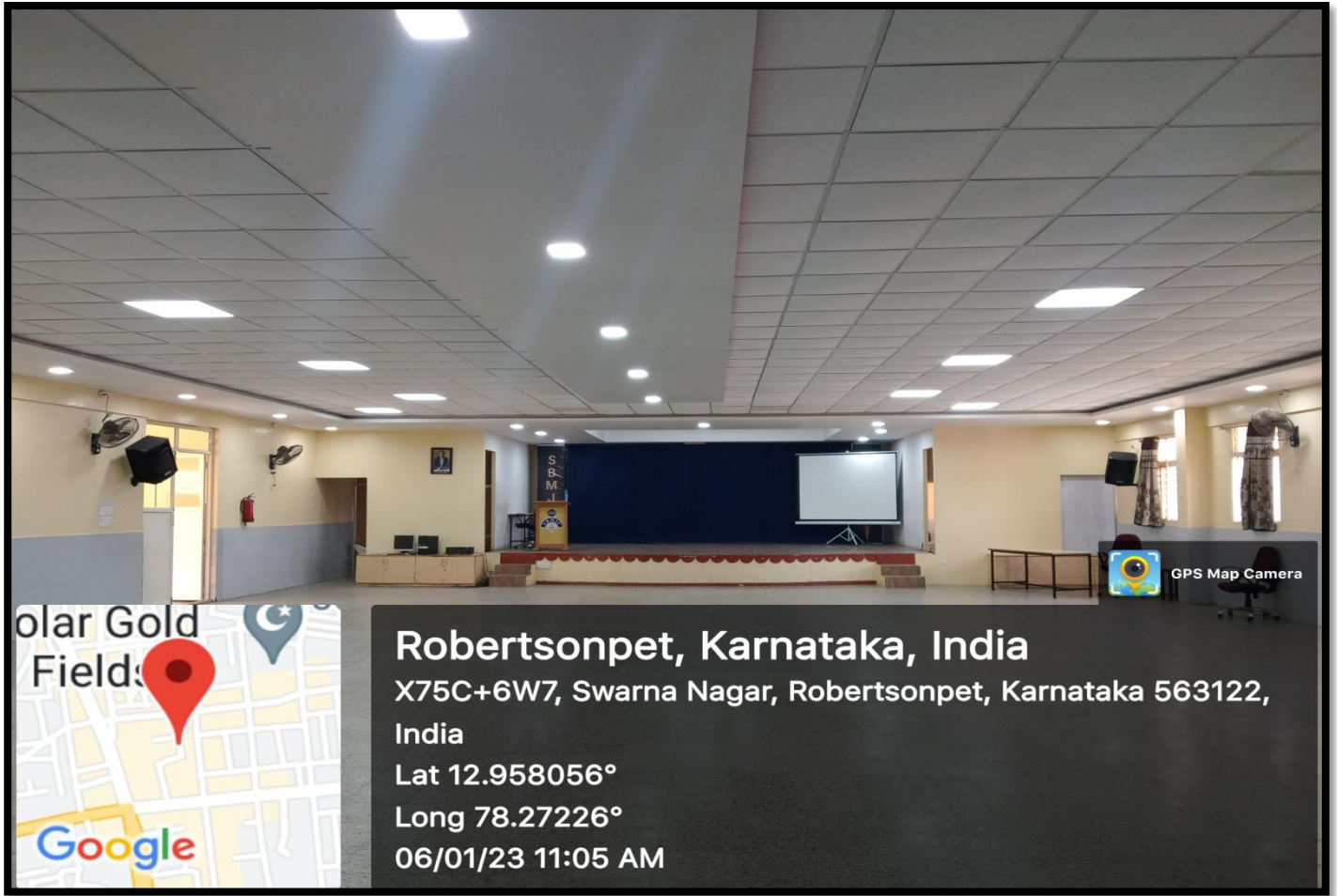
